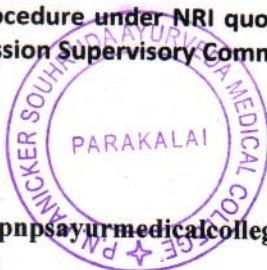

**ADMISSION NOTIFICATION FOR BAMS COURSE UNDER NRI QUOTA FOR 2021-22**

Online applications are invited in the format specified for admission to 7(Seven) NRI Seats for BAMS Course at P. N. Panicker Souhruda Ayurveda Medical College, Parakalai, Kanhangad, Kasaragod from Candidates who have passed in the subject of Physics, Chemistry Biology and English individually at the Higher Secondary Examinations of the Board of Higher Secondary Education, Kerala or examinations recognized equivalent there to and obtained a minimum of 50 % marks taken together in Physics Chemistry and Biology and qualified in the NEET Examination 2021-22 are eligible for admission subject to the conditions given below.

- The students who belong to General Category who have secured 50<sup>th</sup> percentile, General Category of PH candidate who have secured 45<sup>th</sup> percentile and OBC & PH, SC & PH, ST & PH candidates who have secured 40<sup>th</sup> percentile in NEET 2021 are eligible to apply for BAMS course
- Applicants shall furnish scanned copies of their NEET Score Card, Plus II mark sheet, Pass certificate, Age Proof and other certificates to be uploaded along with the online application.
- Copies of the Passport, Visa, Green Card/OCI documents of their respective Sponsors. Job of the sponsors should be mentioned in the any of the above documents. Visa of the sponsor should be valid till the closing date of admission of BAMS Course.
- In case, the employment of the sponsor is not mentioned in the above documents, the candidate has to produce the employment certificate of the sponsor attested by the Embassy/Consulate authorities.
- The certificate clearly establishing in the relationship of the sponsor with the candidate shall be obtained from the revenue authorities as per GO(Ms) No.243/14/H&FWD dated 6-8-2014.
- The relationship between the candidate and his/her father/mother, which are recorded in the educational certificate, maintained in the usual course of transaction by the competent authorities, shall be accepted.
- The candidate shall be produce a sworn affidavit from the sponsor in a stamp paper worth Rs. 200/. The same shall be notarized by the Notary Public, disclosing that the student is dependent of the sponsor and all expenses ie; tuition fee and special fee of the candidate for the entire course period will be borne by the sponsor.
- All certificate/documents required to establish NRI status/Non creamy layer/Minority etc shall be produced at the time of Submission of application itself. The certificate produce later shall not be entertained under any circumstances.
- The Tuition Fee for admission under NRI quota is Rs.3,00,000/- per year for five years.and the Special Fee for 1<sup>st</sup> year is Rs.83406/- and the next four years @ Rs.59244/- per year.
- Issue of Application form begins from 18-2-2022
- The last date of submission of online application shall be on 3-3-2022
- The list of applicants with remarks will be published in our Website and Notice Board on 4-3-2022
- The candidates will be given a chance for filing compliance, if any on 5-3-2022 and chance for correction of entry errors will be given at 5.pm on 6-3-2022.
- The Provisional Rank List will be published at 6.00 pm on 6-3-2022 and publication of final rank list on website and notice board will be on 7-3-2022

The admission procedure under NRI quota to BAMS Course is as per the guidelines and directions issued by Admission Supervisory Committee for Medical Education in Kerala (AFRC)
